HOSPITALITY COLLABORATIVE: HE HOSPITALITY COLLABORATIVE (HC) ADDRESSES THE NEEDS OF THESE VULNERABLE PHILADELPHIA RESIDENTS. THE MAJORITY OF OUR HC GUESTS ARE CURRENTLY HOMELESS OR HOUSING INSECURE AND LACK EVEN THE MOST BASIC NEEDS: FOOD, CLOTHING, SHELTER. IN 2019 THE HC SERVED APPROXIMATELY 6,191 INDIVIDUALS WHO ARE BURDENED BY EXTREME POVERTY. THE HC PROVIDES NUTRITIOUS MEALS, SERVED IN AN INDOOR, FAMILY STYLE SETTING, 5 TIMES PER WEEK TO AN AVERAGE 330 ADULTS PER MEAL. A TRAUMA-INFORMED MODEL OF CARE IS EMPLOYED TO MITIGATE THE TRAUMATIC EFFECTS OF LIVING WITH CHRONIC SCARCITY: THERE ARE FEW LINES (E.G., NO "FIRST COME FIRST SERVED" APPROACH), GUESTS ARE TREATED WITH DIGNITY AND RESPECT, AND THERE IS "ALWAYS ENOUGH FOR EVERYBODY".

FAITH PROGRAMMING: BSM'S RESIDENT WORSHIPPING COMMUNITY GATHERS EVERY SUNDAY AT 4:00 PM TO BE CHALLENGED AND COMFORTED BY SONG, SCRIPTURE, PRAYER, AND SMALL GROUP CONNECTION. BSM WORSHIPS IN THE REFORMED TRADITION, BUT THE WORSHIPPING COMMUNITY IS MADE UP OF PEOPLE FROM EVERY IMAGINABLE [NON-]FAITH BACKGROUND. BSM'S RESIDENT WORSHIPPING COMMUNITY, LIKE THE REST OF ITS PROGRAMMING, EMPHASIZES HOSPITABLE OUTREACH TO THOSE LEAST LIKELY TO RECEIVE IT MEANINGFULLY ELSEWHERE.
